That success is largely due to the talent that we attract by being friendly, open and bound by our love of theatre. It's been great to welcome back previous directors, actors & crew and I'm excited to see new people, ideas & innovations heading our way.

We have a had a great year with 4 fantastically well received, and profitable, shows – "Sweet Charity", "Nunsense", "STiFF" and "Alice the Panto" (technically a 2016 show). Audience numbers have been amazing, with our adult shows all selling 80 - 90% of seats and the turnout for Alice was almost unheard of for a panto.

I've been honoured to be supported by a team who are committed to CTP – although the actors get the applause of the audience, there are countless heroes who enable them to shine. I'm glad we're all volunteers as we couldn't afford to pay Chris & Jenny even the minimum wage for all the time & effort they put in. To Izzy, Maree & Leanne who are leaving the committee – don't go far and come back soon. To everyone else, many thanks for all you've done and I look forward to working with you in the future.

We are indebted to the continued support of our 3 major sponsors - Bendigo Bank, North Shore Realty and Coolum & North Shore News.
